## Bedroom Requirements in Massachusetts (and most areas of the US)

**Note:** While any local building department can allow exceptions to these requirements – <u>ANY BEDROOM NOT MEETING THESE</u> <u>MINIMAL REQUIREMENTS CAN POSE A POTENTIAL HAZARD</u>

## ALL BEDROOMS SHOULD MEET THE FOLLOWING MINIMAL REQUIREMENTS:

**Gas appliance restrictions**: Gas appliances are **not allowed in bedrooms**. (There are some rare exceptions to this – all gas appliances can be potential hazards in bedrooms regardless)

**Fireplaces**: Fireplaces **cannot be installed in bedrooms**. (There are <u>rare</u> exceptions for sealed gas units which get their combustion air from the exterior and are allowed by the local building department) <u>This is important - as a fireplace</u> <u>can consume the oxygen in the room while occupant(s) sleep!</u> Any fireplace in a bedroom should be sealed / made non-functional for safety.

**Fuel tank restrictions**: Fuel tanks are **not allowed in bedrooms**. All fuel tanks should be **at least 10 feet away** from the room.

**Egress window size and height requirements**: Every bedroom must have at least one egress window that opens directly to the outside. The **window must be at least** <u>24 inches wide and 20 inches high</u>, and it must be located **within** <u>44 inches</u> of the floor - no higher. Windows less than 18 inches from the floor must have properly rated safety glass. The window must be located so that it can be opened from the inside <u>without the use of keys or tools</u>. (This means that any security grate over the window **MUST be easily opened from the bedroom**)

Bedroom door size requirements: The door to a bedroom must be at least 28 inches wide and 78 inches high.

<u>Heat source requirements</u>: Every bedroom <u>must have a heat source</u> that can maintain a minimum temperature of **68** degrees Fahrenheit.

<u>Electrical lighting requirements</u>: Every bedroom must have at least one ceiling light that provides at least <u>10 foot-</u> <u>candles of light</u>. (*This is sometimes waived in older buildings with a minimum of 2 electrical recepticles*)

<u>Electrical receptacle requirements</u>: Every bedroom must have *at least one electrical receptacle*. (2 if no light is installed)

<u>Ceiling height requirements</u>: The ceiling height in a bedroom must be at least 7 feet.

<u>Square footage requirements</u>: The minimum square footage for a bedroom is **70 square feet** for a single occupant, **100 square feet** for two occupants, and **50 square feet** for each additional occupant.

<u>Closet requirements</u>: Every bedroom must have a closet that is at least **7 feet wide and 5 feet deep**. (*This is OFTEN* waived in older buildings - and some areas do not appear to enforce this at all)

## Free TIP SHEET – Massachusetts Bedroom Requirements

<u>Window pit requirements</u>: If a bedroom egress window is below grade then there must be a window pit.

Massachusetts bedroom egress window pit requirements:

<u>Window sill height</u>: The window sill height must be <u>no</u> <u>more than 44 inches above the floor of the pit</u>. The window sill should also be a **minimum 6 inches over the bottom of the pit** (to help prevent leaks).

<u>**Pit drainage</u>**: The pit must be **properly drained** to prevent water accumulation.</u>


<u>Pit guardrails</u>: If the pit is *more than 30 inches deep*, it <u>needs guardrails</u>. The guardrails must be at least 42 inches high and have a spacing of no more than 4 inches.


Ladder: If the pit is more than 72 inches deep, a ladder (or steps) must be provided. Ladders must be at least 36 inches wide and have rungs spaced no more than 12 inches apart and be spaced a minimum 3 inches away from the pit wall.

<u>Pit size requirements</u>: The pit must have a minimum width of 36 inches and a minimum depth of 36 inches. The pit must also have a minimum headroom of 60 inches.

Here are some additional requirements:

- The window well **must be accessible** *from inside the bedroom*.
- The window well must be <u>free of obstructions</u> that could impede escape. (*This also means NO locks or other security which needs keys or tools to open*)
- The window well **must be well-lit**.

## For 4 or more unit commercial building bedroom requirements, the following additional requirements apply:

<u>Sprinkler requirements</u>: All bedrooms in a 4 or more unit commercial building **must be equipped** with a sprinkler system. (*This is often waived in older buildings*)

**Egress window requirement exceptions**: The egress window requirement can be waived if the bedroom is located on the first floor and there is an **exterior door that opens directly to the outside**. *The requirement can also be waived if the building has a common hallway with sprinklers, 2 separate egresses, and common hallway self closing fire doors – depending on the municipal building department's judgment*.

<u>Common hallway fire requirements</u>: There must be a <u>fire door between each bedroom and the</u> <u>common hallway</u>. The fire door must be self-closing and have a minimum fire rating of 20 minutes.

When in doubt about a room's ability to be used as a bedroom, **contact your local building department**. (*Do NOT contact the assessor's office – we OFTEN see rooms "called" bedrooms by them that were in fact NOT SAFE FOR USE AS BEDROOMS*)

It is also a good idea to consider installing (or having one on hand) a bedroom "escape" ladder for all bedrooms where the windows are over 6 feet off the ground (These ladders can often be shortened / lengthened to perfectly reach the ground). This will allow safe climbing instead of dangerous "Jumping" to escape a fire.



Note: ALL requirements can change at any time. For maximum accuracy, always consult your local building department on their bedroom requirements.
